12. Footpaths and Bridleways Report for PPC Meeting 26 March 2012

Pony in Wood Lodge Paddock. No further complaints of recent interference by the pony have been received by the Public Rights of Way Officer .

Dog Control Orders Consultation. The consultation has been halted for the present while BANES reconsiders its proposals in the light of comments received.

Dog Fouling in Cricket Club Lane. A further article appealing to the dogs (apparently only 3 or 4) that have spoiled the excellent record achieved from September to December 2011 was placed in the March Link. Starting at the end of February the Dog Warden has been making frequent visits to the lane and marking the deposits with a white spray in an effort to catch the offenders. So far one has been identified and issued with a fixed penalty notice fine of £50.
