AED Report to Priston Parish Council of 16th November 2016.

All maintenance checks have found no problems since last Council.

The new AED and cabinet have been delivered and are ready for installation. I intend for the new cabinet to be installed in place of the current one as soon as it can be achieved. I have received one quote of £250 and am waiting for another contractor to look at the job and quote. That will be in the next few days from this meeting. So there will be a disbursement for the installation.

Unfortunately it is not possible for the new cabinet to have the same code as the old one as the key-pad design is different. This means there will have to be close liaison between us, AED Locator and the ambulance service on the actual timing of the commissioning of the new cabinet. Every household will receive a hand-bill with the new code before commissioning

With regard to the placing of the old cabinet and defibrillator, I understand Council will decide where it is to be placed. If I may make a suggestion, Lower Priston is my preference as the population there is greater than that of Upper Priston. One villager has indicated that it may be possible for it to be fixed to the wall of their house.

As far as the new defibrillator is concerned, that will be commissioned later when the necessary conversion training has been given

I would like it to be placed on record that we are extremely grateful to the village benefactor, who wishes to remain anonymous, for their very generous donation.
